For additional boxes there is a \$25 fee per box. If sending more than two boxes, please complete the payment information on the next page and return to NAPSLO with this form. NAPSLO will not display publications if more than two boxes are received and payment arrangements are not made.

Approved Publications: Publications that report on insurance news and issues will be accepted. Company publications/newsletters, advertising, sales or promotional materials will not be displayed.

Registration Hours: Access to publications (which will be displayed in the Registration Area) is available during Registration hours, 10:00 a.m. to 6:00 p.m. on Wednesday, 7:30 a.m. to 5:00 p.m. on Thursday and from 7:30 a.m. to 1:00 p.m. on Friday.
